31st December 2020 and thereafter were approved by the Board of Directors at their meeting held on 12th February, 2021.

The Company has two business segments i.e. manufacturing of Aluminium Extruded Products and manufacturing Transmission and Distribution 2 Line Hardware. However, the company does not fall under any of the criteria laid down under Ind AS - 108 and hence segment Reporting not applicable.

The above is an extract of the detailed fromat of quarterly results filed with the Stock Exchange under regulation 33 of SEBI (Listing Obligation and 3 Disclosure Requirements) Regulations, 2015. Ind AS 115, Revenue from Contracts with Customers, mandatory for reporting periods beginning on or after April 1, 2018, replaces the existing 4 revenue recognition requirements. As per the assessment of the Company, on adoption of Ind AS 115, there is a decrease in the profit of the Company by Rs. 21 lakhs for the nine months ended 31st December 2020.

As the economy and demand are gradually recovering through "new normal" from the disruption and challenges put forth by the COVID-19 5 pandemic ; company's opeartion and sales are improving and the compnay expects sustainable further improvement in the time ahead. However, as a result of pandemic and lockdown the figures of current quarter and that of nine months ended are not comparable with figures of corresponding quarter and nine months ended.

The management has assessed company's financial position and does not anticipate in its inability to continue as a going conern including recoverability of the carrying value of its property, plant and equipment. The Company has assessed the impact of COVID-19 pandemic on its business operations based on the relevant internal and external information and will continue to do so for taking appropriate action as and when required.
